



These Terms & Conditions govern the ABRSM Music Theory Survey Prize Draw (“the draw”). The draw is promoted by The Associated Board of the Royal Schools of Music, 4 London Wall Place, London, EC2Y 5AU, United Kingdom (“ABRSM”).

## Conditions of entry

1. By entering the draw, you agree to these Terms and Conditions, and to comply with them fully.
2. All eligible participants in the ABRSM Music Theory Survey (“the survey”) may enter the draw. This excludes employees of ABRSM, its subsidiaries, or anyone involved in running the draw. ABRSM reserves the right to verify the eligibility of all entrants. Entries must be made in the name of the survey participant.

4. Entries are open from Thursday 23 April 2019 and must be submitted by 17:00 on Friday 10 May 2019 (the “Closing Date”). No purchase is necessary. Entries received after the Closing Date will not be accepted.
5. Multiple entries from the same participant will not be accepted.
6. Only complete entries will be accepted. ABRSM accepts no responsibility for any entries that are lost, incomplete, illegible, corrupted, damaged or fail to reach it by the Closing Date for any reason. Proof of sending is not proof of receipt.
7. By entering the draw, you confirm to ABRSM that all information submitted by you is correct and that you have complied fully with these Terms and Conditions. Automated entries and entries via third parties or agents will be invalid. Entries that do not comply with these Terms and Conditions (including those containing any false information) will be invalid.

## The prizes
